The regular meeting of the Northport City Council convened at 6:00 p.m. on November 4, 2013 at the Northport City Hall, located at 3500 McFarland Blvd. The invocation was offered by Mayor Herndon. President Logan led the assembly in the Pledge of Allegiance. Upon roll call, the following were found to be present: President Logan, Councilwoman Hayes, Councilman Sullivan, Pro Tem Acker, and Councilman Harper. Also present were City Administrator Scott Collins and Mayor Bobby Herndon.

Mayor Herndon presented a proclamation to Turner & Schoel, Inc. for business of the month for November.

President Logan opened the floor for public hearing concerning the Ordinance for rezoning of approximately 3.6 acres of land located on the Martin Luther King Jr. Blvd., 17<sup>th</sup> Street, 14<sup>th</sup> and 15<sup>th</sup> Court.

Mr. Howard D. Mayfield, 1207 15<sup>th</sup> Street Court, objected to the rezoning due to it being in a residential neighborhood. He said anytime you change the residential zoning to commercial in a predominately residential neighborhood, that is a signal for things to come. He said that if this is approved, he feels there will be more requests in the future and said that would be a drastic change in the future for the neighborhood.

Mr. Lorenzo Freeman, 1504 Juniper Ridge Lane, spoke on behalf of the church and was in favor of the rezoning. Mr. Freeman explained they are trying to bring the church in compliance with the City Codes to make it better for the community. He said this zoning change will help the church enhance the community by offering GED Classes, tutoring for children, and spreading the Word of God. Mr. Freeman thanked the Council for the opportunity to speak.

Mr. Vincent L. Brown, 10131 Magnolia Court Tuscaloosa, spoke in favor of the rezoning. Mr. Brown said the New Zion Missionary Baptist Church has been a staple in the community since 1923 and everything they do as a church has the community in mind. He said the church chose to stay in this community and they want to protect their investment, and not to harm any of the residents. He thanked the council for the opportunity to speak.
